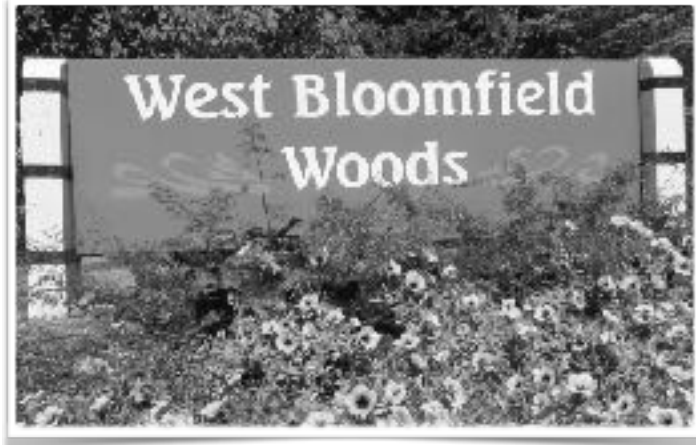

## **HENRY FORD HOSPITAL DRIVEWAY PROPOSAL**

It has recently been brought to the Board's attention that Henry Ford Hospital has initiated plans to create a driveway/two-lane road connecting the parking lot to the east of their Maplegrove Center to 14 Mile Road to the south (see map). An on-site informational meeting was held August 9th, but the WB Woods Board was not notified of the meeting, and only some households within a certain distance from the roadway were forewarned. The proposed roadway would be no closer than 400 feet to any house in our subdivision, but could conceivably create concerns with noise and or traffic congestion, particularly at night or along 14 Mile Road. The current application calls for the road to have an access point directly across from BerryHill Street to the south. This would appear to require some rezoning of previously designated wetlands or woodlands, and has brought some discussion from residents regarding promises made during the initial construction of the hospital.
